SCHOOL MEAL INFORMATION

Breakfast and lunch prices for the 2017 – 2018 school year are as follows:

K - 4	\$1.95	\$2.75
5 - 8	\$2.00	\$2.85
9-12	\$2.15	\$3.00
ADULT	\$2.35	\$3.70

Each meal comes with one carton of milk. Extra milk is available for all grades. The price to students will be .40 cents per carton. <u>There is no free or reduced price for extra milk</u>. All extra milk is .40 per carton whether or not you qualify for free/reduced meals.

The High School has a \$<u>10.00 limit (before the 10 meal limit)</u> for extra food charges (i.e. entrée, dessert, potato or milk). Once a family or individual has reached the \$10.00 limit, they may still charge meals up to the <u>10 meal limit</u>.

Unpaid Meal Charges

The district's meal charging requirements are as follows.

A charge account for students paying full or reduced price for meals may be established with the district. Students may charge no more than 10 meals to this account. Charging of a la carte or extra items to this account will not be permitted.

Any student failing to keep his/her account solvent as required by the district shall not be allowed to charge further meals until the negative account balance has been paid in full or arrangements have been made to pay off the bill installments (policy DP - Collection Procedures) with the Superintendent or the Superintendent Designee. However, such students will be allowed to purchase a meal if the student pays for the meal when it is received. No substitute meals will be provided.

At least one warning shall be provided to a student and his/her parent or guardian prior to denying meals for exceeding the district's charge limit. If payment of the negative balance is not received within 5 working days of the maximum charge limit being attained, the debt will be turned over to the superintendent or superintendent's designee for collection in accordance with board policy DP. If the debt is not paid within 10 days of mailing the final notice of the negative account balance under policy DP, it shall be considered bad debt for the purposes of federal law concerning unpaid meal charges.

EXAMPLE OF 10 MEAL CHARGES

Negative balances are printed at 7:00 am so breakfast & lunch will for that day will not be included in balance. Middle & Elementary School students will bring their bills home once each week. High School students may check with cashier on their balance or check balance through ezschoolpay.com. Please check with your children or check their bags for the bill. You may also at any time check your child's account or make payment at ezschoolpay.com, there is a link on the USD 466 website. Payments can also be made at any Scott County School.

DEPOSITS

If the deposit is made after 9:00, it MAY NOT be reflected on the account until the next day.
